Built collaborations with front-line service providers and other charity organisations to understand the needs of fisherfolks experiencing gender-based violence, providing support and reference for identified cases.

REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF ENCOMIUM 2020

Opinion

We have audited the financial statement of Encomium 2020 which comprises The Statement of Financial Position as at 30th June 2023, the Statement of Comprehensive Income, and the Statement of Cash Flow for the period then ended, and notes to the financial statements, including a summary of significant accounting policies on page 13.

In our opinion, the accompanying financial statements of Encomium 2020 in the year ended 30th June 2023 are prepared in all respects, in accordance with International Financial Reporting Standards (IFRS), comply with the Uganda Companies Act, (No.1) 2012 (Section 170), and the non-Government Organization Act.

Basis of Opinion

We conducted our audit in accordance with International Standards of Auditing (ISAs) and guidelines issued by the Institute of Certified Public Accountants of Uganda (ICPAU). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Organization in accordance with the International Ethics Standards Board of Accountants' Code of Ethics for professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit of the financial statements in Uganda, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and those charged with Governance for the financial Statements

Management is responsible for the preparation of the financial statements in accordance with the International Financial Reporting standards (IFRS),

In preparing the financial statements, management is responsible for assessing the Organization's ability to going concern and using the going concern basis of accounting unless management either intends to liquidate the organization or to cease operations, or has no realistic alternative but to do so. Those charged with governance are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objective is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error. And to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in according with International Standard on Auditing (ISA) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of those statements.

As part of an audit in accordance with ISAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also identify and asses the risks of material misstatements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis of our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control.

We also:

- i. Obtain an understanding of internal controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Company's internal control.
- ii. Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- iii. Conclude on the appropriateness of management's use of the going concern basis of accounting and based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements.

Going Concern

Use of going concern assumption

As part of our audit of the financial statements, we have concluded that management's use of the going concern assumption in the preparation of the financial statement is appropriate as stated on page 4.

Based on the work performed, we have not identified any material uncertainties related to events or conditions that may cast significant doubt on the organization's ability to continue as a going concern that we believe would need to be disclosed in accordance with International Financial Reporting Standards (IFRS). Because not all future events or conditions can be predicted, this statement is not a guarantee as to the organization's ability to continue as a going concern.

Report on Other Legal and Regulatory requirements

As required by the Companies Act (NO.1) 2012 (Section 170) we report to you, based on our audit opinion that:

i. We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of the audit.
